Subject, **PETITION** concerning our application for available radio transmission channels submitted **11 years** ago
 Comments to the official memo ATRP 03.dec.2003 and 18.dec.2003

First I would like to thank the **committee for petitions** and **Dr.Sandra Basic Hrvatin** chairman of the council for radio transmission for there sacrificing work in intervening between the agency ATRP and Radio Mega1.

During the meetings of 03. and 18. dec.2003 we demonstrated our legal interest to the administrative office in hopefully finally ending the proceedings of our application dated 29.03.1993 and issuing a decree.

The agency ATRP in there official comments to the meetings concluded in admitting the unprofessional work of there predecessors, but our deferring points of view in solving the situation have not changed.

We insist upon our statements:

- **UNEQUAL AND ILLEGAL TREATMENT OF APPLICANTS IN THE ADMINISTRATIVE PROCEEDINGS**
- **UNACKNOWLEDGMENT OF PUBLIC PROPERTY, AVAILABLE PUBLIC RADIO FREQUENCIES**
- **FALSIFICATION OF DOCUMENTS**
- **ILLEGAL AND IRRATIONAL ALLOTMENT OF RADIO FREQUENCIES**

The memo from the agency ATRP num 101-36/ 2003/ 5 dated 13.jan.2004 is yet another attempt in evolving a theory of **absurdities that serve the function in justifying the violation of the applicant's rights.**

It is also possible to deduct from the official documents presented by the agency that a **certain applicant on the same date in March 1993 was granted two internationally coordinated frequencies at the same location...**, even that at the time there was no legal basis, and the applicant was not able to content the demands of the governing **LAW OF PUBLIC INFORMATION** (a law that the agency denies the existence of) and the government decree RS 340-09/91-4/7-8 of 10.nov.1992.

During our meeting at the offices of ATRP it was also discovered that there were at the time **29.03.1993, 6. internationally coordinated frequencies that the former agency RUT was concealing.** It was public knowledge that there where 4. unassigned frequencies, but they suddenly disappeared and no new frequencies would be available in the foreseeable future...

THE LIABILITIES OF SUCH INFRINGEMENTS ARE NOT THE APLICANTS RESPONSABILITY.

Therefore we again state the following

- 29.03.1993 we submitted a valid application. The agency RUT did not issue a decree in thirty days which is the legal timeframe. There excuse was the so-called moratorium and we have been forced to wait since sep. 1993.
 - RUT 16.sep.1993 states in the first part of the second paragraph of there letter. **WE INFORM YOU THAT YOUR APPLICATION IS COMPLETE AND WILL BE DEALT WITH, YOU WILL BE INFORMED OF THE PROCEEDINGS.**
 - Our application has not been dealt with and we still have not been informed of the proceedings.
- FOR US THE MORATORIUM IS TILL VALID.**

The so-called **DELETION - CANCELLATION** of our company was done against the will of its owners, and is the result of illegalities in the function of attempting to cover up further illegalities...

We are asking the committee for petitions to acknowledge the obvious discordances in the proceedings.

In the function of defending our legal interests and obtaining a broadcasting frequency we demand the revision of all documents and correspondence of applicants that lead to the unequal priority of some applicants.

Pleas intervene with your authority, so we may obtain our denied rights.
